Since 2013, I undertook and continue to undertake to the present day, duties as a Neurology Consultant in the Intensive Care Department of Anesthesiology, AHEPA Hospital, Aristotelian University of Thesaloniki, Greece, concerning the diagnosis of brain death.

In this laboratory, the cervical and cerebral arteries of stroke sufferers are being evaluated with a Triplex device.

In addition, this laboratory offers the service of transcranial Doppler, which allows the continuous monitoring of blood flow velocities of cerebral arteries in stroke sufferers.

Since the 1-9-2006, I organized, with the assistance of the Director of the Department, and continue to run to the present day, the outpatient clinic of the A Neurology Department, AHEPA Hospital, Aristotelian University of Thessaloniki, Greece, for stroke sufferes.
